

Nomination form for a dependant pension

On the death of a member of the Mineworkers' Pension Scheme (MPS), a pension may be payable to a surviving spouse, civil partner or financial dependant.

If you are not married or in a civil partnership, this form allows you to nominate someone to be considered for a dependant pension in the event of your death. This person must be financially dependent on you. Please note that completion of this form is not a guarantee that a discretionary pension will be awarded to your named dependant. However, it will inform the Scheme of your wishes.
