Important notes

- If you die before you've been taking your MPS pension income for five years and before your 75th birthday, we may pay your beneficiaries a lump sum. This lump sum will be worth the remaining payments you would have had in this five-year period.
- This form allows you to let us know who you wish the Trustees to consider, to receive any lump sum benefits that may be payable when you die.
- You can cancel or vary this declaration setting out my wishes at any time, by completing a new Expression of Wish.
- Since the Trustee has complete discretion regarding payment, this normally means that under current tax rules the lump sum paid is not considered part of your estate and is, therefore, free of inheritance tax.
- It should be stressed that 'the discretionary system' and the Expression of Wish apply only to the lump sum death benefit and not to any other entitlements which may become payable on your death.
